Information

Summary

The group's assignment has been given by the non-governmental organization named Global Human Rights Defense. This assignment consists of several sub-assignments that will be completed throughout the year.

This team is the only group from the annual layer to deal with a year assignment.

This means that they will carry out this assignment under the supervision of the same client during an entire school year, in their case for Global Human Rights Defense.

Normally this is not the proposition, because all of the teams are supposed to do two assignments in the fifth grade, which means they all come into contact with two clients. But because of the quality of this assignment, the group has decided together with their teachers, to make it a full year project.

Two deliverables are planned for October.

One is an online web base workshop, given by Global Human Rights Defence. It will take place on October 23rd.

The second deliverable on the to-do list in October is the preparation of two interviews, which the team will conduct with two MPs. The interviews will take place on 15 November 2020.

After all these completed deliverables, the team will work towards the big day: International Human Rights Day. Which will take place on December 10, 2020, in the Peace Palace in The Hague.

On this date Global Human Rights Defence (GHRD) will also launch their new concept; Global Human TV.

The schedule for 2021 is unstable due to corona. But the team has already received a foretaste of the likely partial assignments that they will carry out then.

In January there will be meetings with organizations and donors.

In February they will travel to Geneva for live interviews with the United Nations.

And finally, in March they will go to Brussels, to attend a meeting with other young European people.

Our client

Shri Shradhanand Sital is the Chairman of Global Human Rights Defense.

This is an international human rights organization based in the Netherlands.

Global Human Rights Defense fights for human rights in countries where population groups have no rights and are victims of poor living conditions.

Global Human Rights defence is an international human rights organization with the objective of promoting human rights for those areas where severe violations have victimized relatively large populations. Up until date millions of people continue to live in the margin of society lacking effective attention from the perspective of governments, development aid, human rights organizations and media authorities, in spite of mankind's joint effort to build a detailed human rights legal framework, based on the Universal Declaration of Human Rights (UN 1948) and followed by covenants, treaties and implementation mechanisms.

Yasmine Khamma is an employee at Global Human Rights Defense. She guides the group during this project.



The assignment

The team has received several small partial assignments for this project. The assignments together should ultimately ensure more recognition of human rights among young people. The different assignments are all linked.

- October 23: The team must all individually make a video about who they are and what you stand for. In this video you have to introduce yourself and say what is important to you.
- October 28: The team must prepare two interviews of eight minutes per interview. The interviews are for two MPs, who may be chosen by the team. The team must write an email asking for an interview about human rights, then the email will be sent to the elected MPs via Global Human Rights Defense.
- November 15: If the interviews are prepared and there are two members of the Chamber interested in the interview, the interviews will be held before November 15. The interviews must be edited and submitted by November 15.
- December 10: December 10 is the launch of Human Rights TV. The launch is in the vredespaleis in The Hague. The team has to present an hour and a half during the launch of Human Rights Tv. During this hour and a half, a debate is organized with young people in other countries. During the one and a half hours that the team has to present, the interviews of the MPs are broadcast.

Assumptions and risks

First of all, it's good to realize that this is an uncertain time, under which the assignment can therefore also suffer.

Especially in 2021, when a lot of trips and meetings are planned, it's important to be aware of the fact that there exists a chance that these cannot continue. All because of COVID-19. The group has to be well prepared for this, so that the assignment can still proceed through another way, for example online.

During the whole project, COVID-19 or not, it's important to maintain good communication within the team. Especially in this project, where communication is the key. It must go well within the team first, so that the team their skills are clearly visible during the project.

For example when they will be conducting the 8 minute long interviews.
